## General conditions of sale

## **PARTICIPATION**

The customer expressly acknowledges that skiing is not a contraindication. The customer agrees to follow the instructions given by the instructor or high mountain guide and to have insurance for the risks associated with winter sports.

## **EQUIPMENT**

Equipment suitable for winter sports is essential, the customer agrees to provide it himself. Aventures-ski will only be responsible for the equipment provided by him.

#### **SAFETY AND SUPERVISION**

Our instructors and high mountain guides are independent professionals with state diplomas in their specialty. The functionality of any program is subject to the assessment of the instructors and guides according to the weather conditions, snow conditions and the moral and physical aptitude of the participants.

#### **INSURANCE**

The instructors and high responsibility mountain guides have taken out professional insurance.

It is the customer's responsibility to insure themselves individually for search and rescue costs, helicopter rescue, medical costs, assistance, repatriation, in the event of an accident, illness or injury.

PRICE: the price indicated when booking only includes the ski or mountain teaching service.

Ski passes, equipment rental, transport, accommodation are the responsibility of the customer.

# RESERVATION, REGISTRATION AND PAYMENT

Registrations for courses only become final when they are confirmed by the customer and accompanied by a payment corresponding to 100% of the total price. The balance is paid before the start of the activities.

# **EXCLUSIONS**

The instructor or mountain guide reserves the right to exclude at any time a person whose behavior is likely to disrupt the progress and safety of the teaching or service.

#### **CANCELLATION**

#### DUE TO THE CUSTOMER

In principle and in any event: from 10 days before the date of the mountain courses or activities, any withdrawal or cancellation (including weather conditions) will not give rise to any refund or report. Any service interrupted or not used due to a defective physical and/or technical level will not give rise to any refund or exchange of service. In the event that the customer is unable to attend the course at the scheduled time or date, whatever the reasons, no claim will be accepted and no refund or report will be made.

Except in the event of an accident, mountain courses or activities will be refunded upon presentation of a medical certificate in proportion to the days not taken.

In the event that the customer is unavailable (except in the event of an accident) during the duration of their stay and therefore cannot attend the activities they have paid for, they will not be able to obtain a refund unless they take out cancellation insurance such as "Carré Neige". In this case, a certificate of non-refund will be provided to you upon request. The schedules of the courses and mountain activities may be modified according to the opening and closing times of the ski lifts.

## DUE TO AVENTURES-SKI OR DURING THE SERVICE

In the event of a stoppage of the regulated courses at our discretion, stoppage of the ski lifts for the entire day and throughout the ski area, the service will be refunded.

In the event of bad weather, safety measures, **temporary stoppage** of the ski lifts, etc., no refund will be made.

The instructors and guides reserve the right to modify, with or without notice, any program according to the weather or safety conditions without any of the participants being able to claim any compensation.

Aventures-ski or the instructor or high mountain guide reserves the right to cancel a ski course or a mountain activity, if the conditions make the practice dangerous. In this case, the days will be refunded at 100% depending on the duration of the cancellation made by the professional.

## **OUR RATES DO NOT INCLUDE FOR ALL SERVICES**

Cancellation insurance, individual insurance, ski lift pass, or equipment location.
